Aquatic Therapy Makes a Big Splash

Is there anything more common than a 3-year-old boy playing in a swimming pool on a hot August day? But there is nothing typical about this day, this pool or this boy.

It's therapy day for Jake Self, the son of Carolyn and Anthony Self of Barling. Jake was born 13 weeks prematurely and his parents were told that because of bleeding in his brain, he would have severe physical disabilities, including being deaf and blind. So the fact he walks through the doors at The Gregory Kistler Treatment Center For Children saying, "Pool, pool, pool!" is, to say the least, a miracle.

The pool he is so eager to spend time in is a miracle of sorts, also. The Kistler Center has always been on the cutting edge of pediatric therapy. The late Wayne Kistler, one of the Center's founders, had to build equipment for the Center in the beginning because it was impossible to find therapy aides suitable for children. When the Center opened in its current location in 1996, the pool was the crowning jewel. It remains one of the few centers with a therapy pool in this region.

Because Center executive director Jennifer Kistler is a swimmer herself, she understands how beneficial time in the

water can be. When her daughter, Michelle, was born with spina bifida, Jennifer had a pool built in her back yard. Michelle, who died in 2003, had no use of her legs but became a powerful swimmer, giving her greater confidence. Because the benefits were so obvious, for years Jennifer allowed the Kistler therapists to bring kids to her pool.

What Jake does in the pool isn't much different than what any other child does but it's different for Jake. On land, he uses a walker but in the water, it's another story.

"It's amazing to see legs that don't move on land working like this in the water," physical therapist Adele Glensky says during a recent pool session with Jake. "They can do things in the water they've never done before."

His mother agrees.

"We've only been doing it a few weeks, but I definitely notice a difference with him getting around in our pool," Carolyn says. "Now, he doesn't want to cling to you."

Jake began therapy at the Kistler Center when he was about 5 months old. Carolyn says he was behind in all of his developmental milestones and, although their struggle isn't over, she sees progress. "I always wonder, if we hadn't come to the Kistler Center, would he have been able to sit up, crawl and use his walker?"

And improvement continues. Sometimes, Carolyn said, Jake will let go of his walker and just stand there and he's able to "cruise" while holding onto things around the house. One time, Carolyn remembers, she noticed Jake and his 2-year-old sister, Molly, had gone outside without telling her. She found the two of them in their older

brother's treehouse -- Jake's walker sitting at the bottom of the tree.

Aquatic therapy starts where the kids are, just like in swimming lessons. The kids have to be comfortable, both physically and emotionally. The Kistler pool is heated and the warm water helps them relax and helps their muscle tone. Adele said the goal is to get arms and legs working together, which is more difficult for some children than you would imagine.

About three dozen kids have aquatic therapy each week. The Center has a 1-on-1-plus-1 policy, which means one child, one therapist and one other person for safety. Adele uses floating devices to get Jake into different positions in the water. She puts a "pillow" behind his head or gives him a noodle to hang on to and encourages him to move around in the water but Jake needs a goal. He's not going to do all that work to get across the pool for nothing.

Jake and Adele are never still. Even while he sits on the stairs in the pool, Adele is stretching the muscles in his feet while Jake unknowingly works the muscles in his hands by showering her with a squirt toy -- this only after he has stood in the water and stretched to retrieve it.

"The body is lighter in water and allows the kids to get upright easier," Adele says. "They're not inhibited by gravity in the water like on land."

The left side of Jake's body is more involved, so Adele encourages him to reach for toys and pour water with his left hand. He occasionally struggles to put his right hand into play but he's so involved in what he's doing, he quickly turns back to his task.

Using the pulling motion similar to what you see on a BowFlex infomercial, Jake struggles against the resistance of the water to "crash" Styrofoam barbells in front of him. He repeats this exercise - or trick, if you're Jake - to the delight of his audience. The bigger the laugh, the bigger the crash.

Jake gets "land" and "water" therapy, as well as speech therapy and occupational therapy, several times a week from different Kistler therapists, which Adele thinks is a good idea. "More than one therapist gives you more sets of eyes," she says.

His mother's eyes are also watching. "He gets around in the pool just as well as anybody else." Carolyn says wistfully.

"I feel like I've dedicated half my life to therapy and I wouldn't do it if I didn't believe in it," Carolyn says. "Having the Kistler Center is crucial. We're fortunate that we have jobs and good insurance but without the Kistler Center, a lot of kids would have to go without therapy."

But that's all a little too complicated for Jake. To him, it's all just another day at the pool.

Miss Martha To Leave After 27 Years

After 27 years at The Gregory Kistler Treatment Center for Children, physical therapist Martha Osburn is retiring.

She began talking to center executive director Jennifer Kistler last spring about leaving. Martha now is down to treating about half a dozen patients one day a week.

Martha was pregnant with her oldest son when she started working in 1979 as the second therapist at the Kistler Center, then located in the old Sparks Nurses School building. She and her husband, Bill, have two sons: Josh and Nathan. Josh is finishing his 4th year of medical school in Dallas and is beginning interviews for his neurosurgery residency. Nathan is a scientist at the University of California at San Francisco doing medical research for children with brain disorders. He plans on attending medical school to become a research physician.

She now will devote more time to her extended family, including visiting her sons, and her work as coordinator of parish religious education at Immaculate Conception Church, which she has been doing on and off for about four years.

"It's time for me to look at other things in my life. I have so many interests, and ministry is one of them," Martha said. She also believes her work at the Kistler Center has been a ministry.

"I have seen miracles happen," Martha says earnestly. "The joy the children has brought me – that happened every day." "Having worked with us since nearly the beginning, Martha has a special

understanding and gratitude for what this building and the Kistler Center represents that will be missed when she is gone," says executive director Jennifer Kistler. "She has been a life long friend of my family as well as a skilled and dedicated therapist. We expect Martha to have a continued presence in our mission."

Empowering parents has been a big part of Martha's focus while at the Center because she believes continuing therapy at home is of the utmost importance to progress for children.

"I've really loved treating babies, giving those young mothers confidence that they can do this," she says. "They don't always understand what a difference they can make in their children's lives."

The biggest change she has seen has come from progress in medical treatment, as well as early intervention. While in training at Easter Seals in Dallas in the 1970s, they never saw patients before they were 2 years old. "When I first started treating extreme premies, they had more severe problems," Martha says. "Now, because of medical advances and early treatment, that same number of weeks (gestation) doesn't mean the same outcome."

A recent occurrence has been the most rewarding for Martha. She has begun to reconnect with some of her early patients who are now young adults.

"They just wanted their old physical therapist because they knew I would understand their bodies and what they had been through. They hoped I would remember things and I did."

Recently, a 27-year-old former patient who had contacted Martha suggested to a friend who has cerebral palsy that he also call her. He didn't realize it, but Martha had treated his friend too.

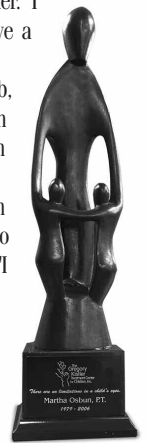
She usually talks with them over lunch, helping them come up with a home program to work on some of the difficulties they are currently having. But the help goes both ways. Martha said she came out of the visits with an education, too. The young men were able to share with Martha what was important to them about therapy and how they were feeling when they were 12 or why they did something they did at the time.

She said it made her feel good to know these young men were also helping each other. "I was so proud of my boys. They have a great spirit."

As far as that final day on the job, it will be bitter sweet for the woman that has seen an explosion in growth for the Center.

"I walk around the clinic and listen to the children laughing. I just so appreciate the clinic," Martha says. "I might retire but I'll never leave."
