## Justin's Story - Accomplishing His Dream

**In memory of Justin Fujibayashi, 1981 – 2006, as told to Ralph Smith by Justin's dad, Carter.**

Carter, tell me how you became acquainted with the Kistler Center.

"I'll have to go back a few years. Justin was born in 1981, and his mother was diabetic. We found out about it several months before he was born. He was born about five weeks premature, but because she was diabetic he weighed 10 pounds. He was large, even though he was premature. He had a lot of respiratory problems since his lungs were not fully developed.

Justin was in the neonatal center at Evanston Hospital near Chicago. We stayed in Chicago, since both of us had pretty good jobs. In 1986, we moved to Arkansas where my maternal grandparents lived to help my sister take care of them. We sold our house and moved down here when he was five years old. He was having extreme difficulty walking. We found out when he was a year old that he had asthma, not cystic fibrosis as we had initially thought. Then, there came the many years of treating the asthma. When Justin was one year old, he was still having difficulty walking. At about two years old he was walking while holding on to something and was sleeping in a fetal position. We had taken him to several specialists in Chicago and they thought he

would just out grow it. They called it the 'floppy child syndrome'. Right after we moved here, one of my sister's close friends asked me how long Justin had had cerebral palsy. I did not know at the time what that was. This was back in late 1986. Surprised and confused by her question, I took Justin to a doctor she recommended and he in fact did diagnose him with cerebral palsy. He made an appointment for us with a doctor at Children's Hospital in Little Rock. There, a CT scan showed that he possibly had suffered a stroke between conception and one year of age. The stroke left part of his right side with limited ability. The hospital as well as my sister recommended we check out The Gregory Kistler Treatment Center.

We took him there for evaluations by physical and occupational therapists, and they felt that they could help him. At first, he received therapy several times a week at the Center. He was walking on his toes on his right foot and his right arm was drawn up across his chest. They did exercises to strengthen his arm and leg. When he was about eleven years old, his right leg was found to be about an inch shorter than his left. The doctor recommended surgery on his leg to keep his foot flat to help him walk. This allowed him to walk with a flat foot and he gained about a quarter of an inch more in length in the right leg.

He received occupational therapy at The Gregory Kistler Center all the way up through the sixth grade. At that time, he began treatment at school. A therapist would treat him at the school in Greenwood, and did that until about the eighth grade.

The Kistler Center made us realize that Justin didn't have to continue to be handicapped. He could run around by the third or fourth grade. He played on the soccer and baseball teams and even went out for football. He was just as active as the other boys and without the Kistler Center, he certainly wouldn't have gotten that far.

Justin showed a great ability to draw from an early age. He drew with his left hand. His work kept getting better and he was very creative. He ended up graduating high school with honors.

He married a girl he knew in school, his best friend Greta. She went to U of A in Fayetteville and he was going to UAFS and working for Malco Theatres at the mall as a projectionist. After he graduated with a degree in Commercial Art, he moved to Fayetteville. When she graduated, they married and moved up north of Topeka, Kansas. They had one child, Henry, and were expecting a second

before his untimely death in December, 2006. Justin was able to live out his dream to be able to draw for a living. There was a movie production company in Dallas that wanted to hire him for some story boards. He was to graduate from Washburn University in Topeka, Kansas, with a degree in Fine Arts the Friday after the week he was killed by a person who was driving the wrong direction on an exit ramp from a divided highway after she left a bar."

**Editor's note: Although Justin's story does not leave us with the totally happy ending that we would desire, there is room for joy. Joy in remembering a life well lived, with the help of knowledgeable care that focuses not on limitations, but on possibilities. Justin did accomplish his goal in life and was a happy, productive and loving son, husband, and father.**

## PLAINLY SPEAKING

Cerebral palsy is a broad term that encompasses many different disorders of movement and posture. These disorders are caused by a brain injury that occurs before birth, during birth, or within the first few years after birth. The injury does not damage the child's muscles or the nerves connecting them to the spinal cord – only the brain's ability to control the muscles. Depending on its location and severity, the brain injury that causes a child's movement disorders may also cause other problems. These problems can include mental retardation, seizures, language disorders, learning disabilities, and vision and hearing problems. Because cerebral palsy influences the way children develop, it is considered a developmental disability.

There are many types of cerebral palsy and more than one method of classifying it. Cerebral palsy is a condition that affects muscle tone, the amount of tension or resistance to movement in a muscle, resulting in high tone, low tone, or fluctuating tone. There is a classification system based on the location of the brain injury, and another based on the location of the movement problems.

Although children with very mild cerebral palsy occasionally recover by the time they are school-aged, cerebral palsy is usually a life-long condition. Many factors can impact the long-term affects of cerebral palsy, including a child's attitude toward cerebral palsy, family support, and the medical, educational, and therapeutic care the child receives.

The Kistler Center staff use an interdisciplinary approach toward cerebral palsy and developmental delay, through which physical therapists, occupational therapists, and speech-language pathologists work together to ensure the most comprehensive treatment for each infant and child. Parents and caregivers are included in therapy sessions, and family support is a significant part of the care provided by the Kistler Center.

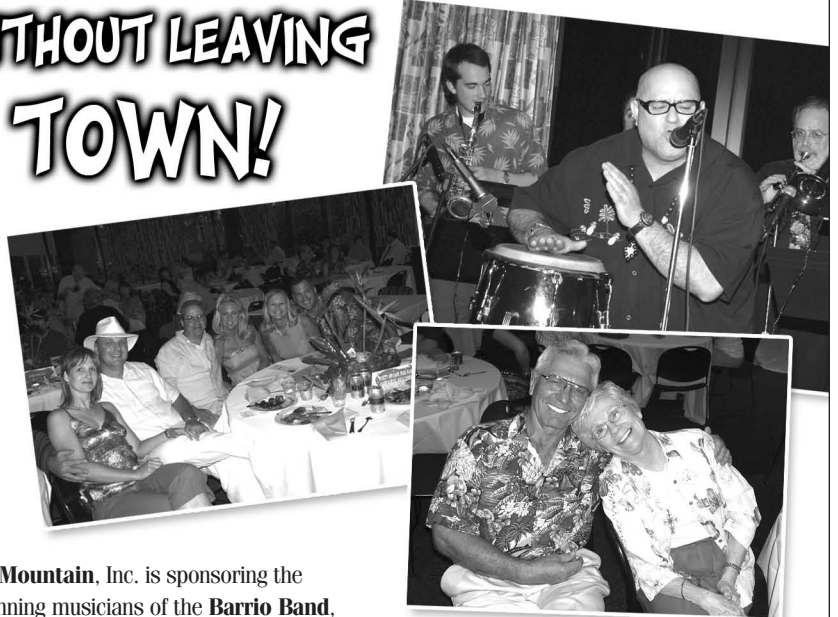
